Investment Objective

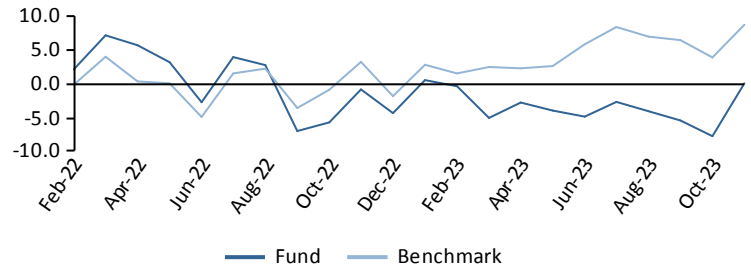

Investment Policy

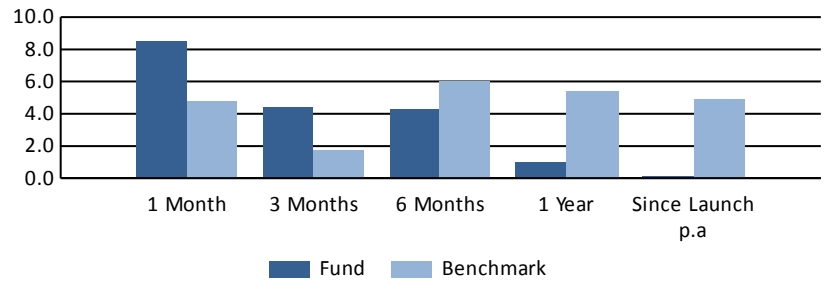

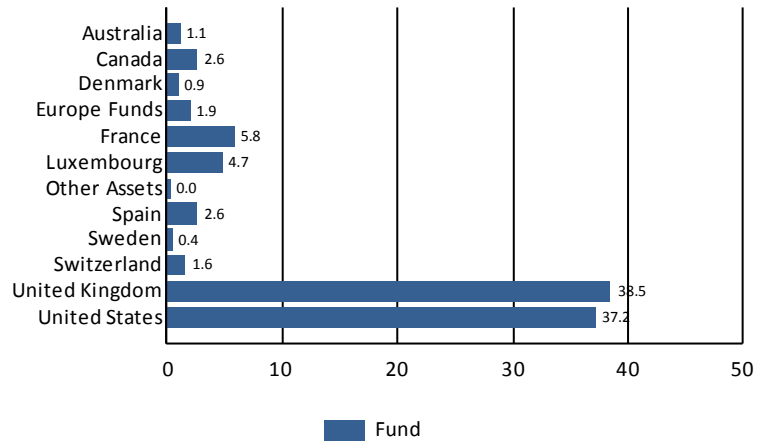
