

EMERGING MARKETS EQUITY ALPHA FUND

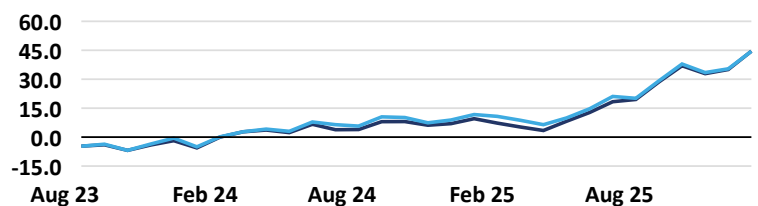
Investment Objective

The fund aims to provide a total return (income and capital) which outperforms the total return of the MSCI Emerging Markets (Net) Index by at least 2% per annum over rolling 5-year periods (after fees and expenses, including the calculation of the ACS Manager's Annual Management Charge).

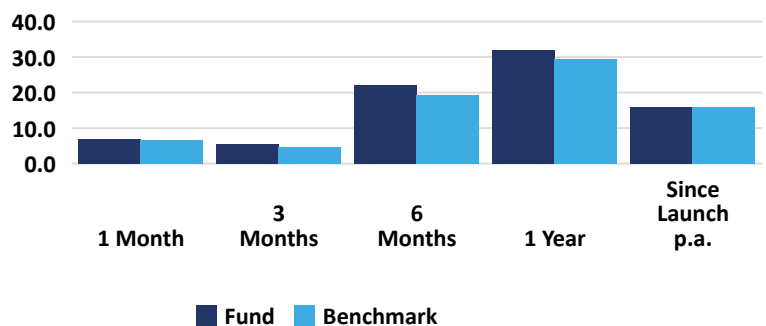
Investment Policy

The fund invests primarily in listed equities of companies from countries which are included in the index. Fund management may be delegated to between two and five external investment managers. The fund is not currently using derivatives for either investment or efficient portfolio management purposes. In the event that Border to Coast intends to use derivatives for either of those purposes within the fund it will give Unitholders 30 days' notice and may make use of stock lending.

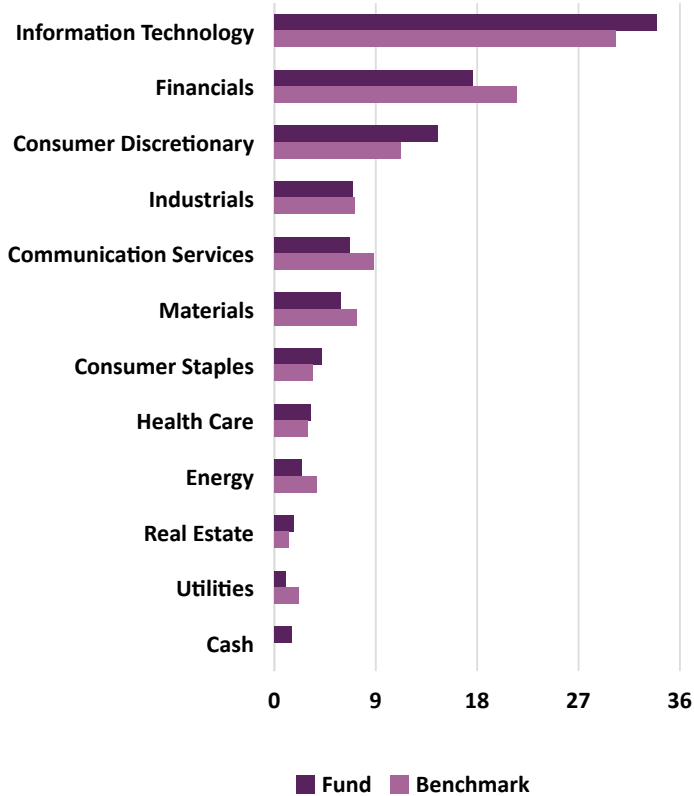

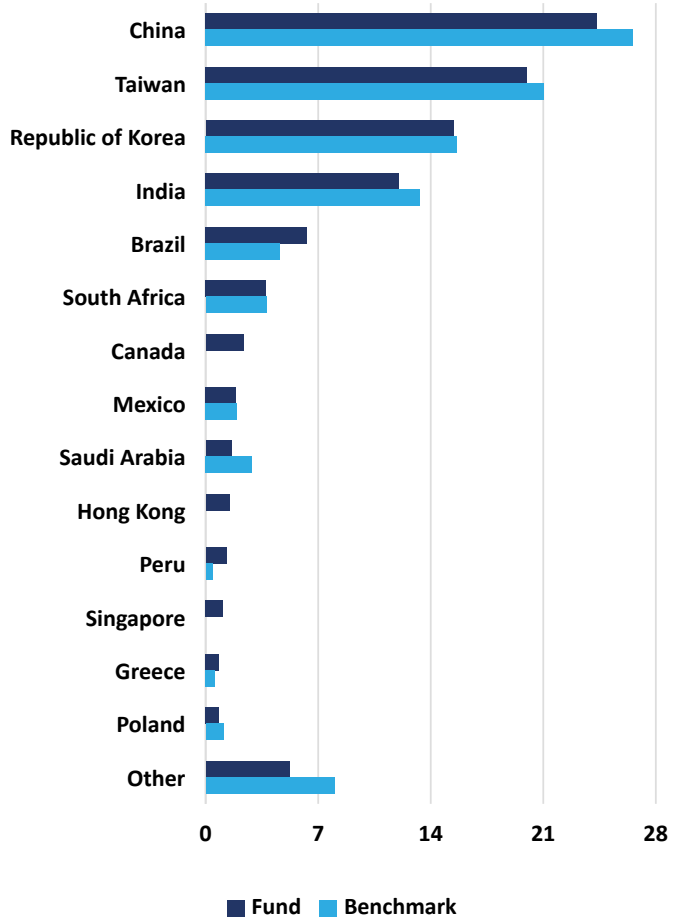
